If invoices are not settled by their due date the we may charge late payment interest in line with current guidelines for late payment of debts. All new accounts will be subject to a credit check.

Subject to our discretion, we may agree to discounts on certain orders. We reserve the right to remove this discount in full if invoices are not paid by their due date.

Companies that wish to pay by Invoice must first place an order on a Pro-Forma basis. The invoice should be paid prior to despatch.

In some cases we may, at our own discretion, choose to despatch orders prior to receiving payment - however, in such cases - the Invoice shall be due for immediate payment on receipt of goods.

Payment of invoices can be made by Cheque - made payable to Cleanroom Supplies Limited - or by Bank Transfer. Please contact us for bank details if required.

Orders can only be accepted if you have a customer account. Accounts can be created online via our website or by e-mail or fax. We do not accept telephone orders. This is to protect both our customers and us from fraudulent activity.

The 'Pay by invoice' option for payment on our website shall be approved at our discretion. We reserve the right to refuse supply of goods to individuals whose credentials cannot be verified.

For all account customers (excluding Pro Forma invoices) payment is strictly net 30 days from date of invoice. We may charge 7% interest above Bank of England base rate on any accounts not settled by their due date. Goods remain the property of Cleanroom Supplies Ltd until paid for in full.

With respect to new customers, we reserve the right to request that the initial order be on a Pro-Forma basis ? allowing payment to clear prior to shipment of the goods.

DELIVERY

In the event of delivery not being possible to mainlandUK within the time periods indicated on our website, we will undertake to keep you informed of any changes and give you the option to cancel your order and receive a full refund of money paid.

UK Delivery is by UPS or Royal Mail. Typically, despatch of stock items are within 1-3 working days. This is not guaranteed - and unfortunately, we cannot guarantee, or be liable for the services of 3rd parties such as Royal Mail and UPS.

Where next day delivery is stated as being available - please contact us by telephone after placing your order online to request this, otherwise our standard delivery will apply.
